#### 1. Key dates:

- Last date of receipt of Applications: 20th September, 2025 (Saturday).
- Award Function: 20th December, 2025 (Saturday)
- 2. The general eligibility criteria and terms and conditions are given at Annexure-I.
- 3. The details of the Categories of Export Awards and the eligibility in addition to general eligibility, are given at **Annexure-II**.
- 4. The format of Chartered Accountant Certificate is given at Annexure-III.
- 5. The format for a brief profile of the Chairman or CEO or Managing Director who shall be receiving the award is given at **Annexure-IV**.
- 6. The Application format is enclosed at **Annexure-V** for reference. Applicants are, however, advised to file their applications through the online portal.
- 7. The awards are for the aggregate of the two years (2023-24 & 2024-25)
- 8. A company may apply for award in more than one category. However, the award will be given in one category only even if the company qualifies for award in more than one category.
- 9. Award will only be given if a suitable number of applications are received.

All applications for Export Awards must be received **in the closed envelope** latest by **20**<sup>th</sup> **September, 2025 (Saturday) to** Shri Sanjay Dudeja, Additional Director, Apparel House, Institutional Area, Sector 44, Gurugram (HR) - 122003. Applications received thereafter shall **not be considered.**

The decision of an independent **JURY** shall be final and no correspondence in this respect shall be entertained. It would be mandatory for the applicant to come in person to receive the award.

The Council reserves the right to reject or not entertain any application.

Mithileshwar Thakur Secretary General The eligibility criteria and terms/ conditions for grant of awards for the year 2023-24 & 2024-25 applicable across all categories are given below:-

- a) The criterion for considering the awards would be the export performance during the FY 2023-24 & 2024-25. The award is open to those who are member of the Council under the Foreign Trade Policy of the Government of India. The applicant must have paid AEPC subscription for the year 2023-24 & 2024-25.
- b) Applications for grant of Export Awards will be considered subject to the condition that nothing adverse about the business dealing of the applicants has come to the notice of the Council and/or other authorities.
- c) Items of exports for grant of Export Awards include all type of readymade garments (RMG) falling in HS Code 61 & 62.
- d) Export Performance should include only those exports in respect of which export proceeds have been realized in applicant's name.
- e) Export Performance should include the value of only those manufactured products which are exported from India. The Chartered Accountant's Certificate should clearly specify this.
- f) For grant of award in each category there should be minimum 3 applications.
- g) No application for Export Awards would be considered if the application forms are not properly filled-in. Incomplete applications are liable to be rejected. Applications received after the due date is also liable to be rejected.
- h) The export figures are to be given by the exporters in terms of FOB value of exports for the actual exports effected in the relevant category during the financial years 2023-24 and 2024-25. Only direct exports will be considered for the purpose of selection for the export awards.
- i) FOB value of exports should be the value of exports excluding commission paid/payable to overseas agents/importers only. The exporters will have to produce a Chartered Accountant's Certificate certifying export turnover in the relevant category. The CA Certificate should contain a declaration from the Chartered Accountant specifying that the figures provided by the applicants have been verified and found to be correct by them and that it is excluding commission paid/payable to overseas agents/importers only.
- j) The aggregated performance for FY 2023-24 and 2024-25 will be considered.
- k) AEPC will be checking all applicants' details from RCMC & and shall carry out due diligence to confirm that:
  - i. The payment has been duly received.
  - ii. There is no vigilance case against the applicant.
  - iii. The export performance mentioned includes 'Direct Exports' only.
